Friday, 02 April 2010

Call to Order: The Regular Monthly Meeting of the Southern Arizona Veterans' Memorial Cemetery Foundation (SAVMCF) was called to order promptly at 0900 hours, Friday, April 02, 2010 by President Tom Dingwall, (AMVETS) with the Invocation and the Pledge of Allegiance.
