That part was satisfied and the order was placed. The programming will be done as a Girl Scout "golden" award project. The Kiosk will arrive within 4 to 6 weeks and will be place east of the HSRP.

To save money year after year, we talked of using artificial wreaths. The best deal we have found is from a manufacturing company in China. The Company is: _______.

They will send a free wreath sample, but we have to pay the postage of \$45.00 - down from one-way shipping of \$80.00. As for the large order of wreaths we will need, they only ship to Los Angeles and we would have to arrange shipment from Los Angeles to Sierra Vista.

If anyone here has contact with a trucking company we sure could use their help.

If we go with the Artificial wreaths [since we have a credit of 25 wreaths with WAA] we would like to use all the live wreaths for the "OLD" burial section - which would require about 61 wreaths - less the credit of 25 leaving us to buy 36 wreaths, at a cost of about \$360.00.

If we go with the artificial wreaths, which will save money in the long run, then we will need to have a storage shed located on the Cemetery site.

Carillon Project: Leo Pimple [AMVETS] reported – for those who missed the raising of the bells last Thursday, that the Bell Tower is up and will be running before 1400, Monday, 31 May 2010, when they will be formally be dedicated – at the SAVMC; followed by the Annual Memorial Day Remembrance Ceremony. All this will be followed by an Open House at the VFW Hall to include free finger food and beverages [to include beer and wines].
